NOTIFICATION

Whereas the draft of the Karnataka Civil Services (Performance Reports) (Amendment) Rules, 2020, was published as required by clause (a) of sub-section (2) of Section 3 read with Section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) in Notification No. DPAR 26 SCR 2020 dated: 19.06.2020 in Part IV-A (No-210) of the Karnataka Gazette Extraordinary dated: 19.06.2020 inviting objections and suggestions from all persons likely to be affected thereby within fifteen days from the date of publication of the draft in the Official Gazette.

Whereas, the said Gazette was made available to the public on 19.06.2020

And whereas, no objections and suggestions have been received in this behalf by the State Government.

Now, therefore, in exercise of the powers conferred by sub-section (1) of Section 3 read with Section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990), the Government of Karnataka hereby makes the following rules, namely;

RULES

1. **Title and Commencement.**- (1) These rules may be called the Karnataka Civil Services (Performance Reports) (Amendment) Rules, 2020

(2) They shall come into force from the date of their final publication in the Official Gazette.

**2. Amendment of Rule 2.-** In the Karnataka Civil Services (Performance Reports) Rules, 2000 (hereinafter referred to as the said rules), in rule 2, in sub-rule (1), in clause (c), for the words, "in respect of Group-B and C officials" the words "or electronically in respect of such category of Group-B and C officials as specified by the Government" shall be substituted.

**3. Amendment of Rule 3.-** In rule 3 of the said rules, in sub rule (2), in clause (a), for the words, "in respect of Group-B and C officials" the words "or electronically in respect of such category of Group-B and C officials as specified by the Government" shall be substituted.

**4. Amendment of Rule 4.-** In rule 4 of the said rules, in sub rule (1), for the words, "in respect of Group-B and C officials" the words "or electronically in respect of such category of Group-B and C officials as specified by the Government" shall be substituted.
