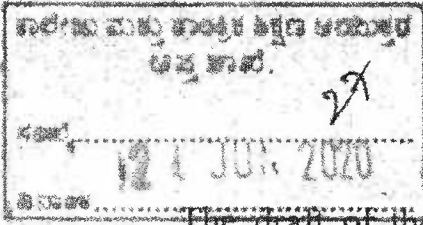

NOTIFICATION

The draft of the following rules further to amend the Karnataka Civil Services (Direct Recruitment by Competitive Examinations and Selection) (General) Rules, 2006, which the Government of Karnataka proposes to make in exercise of the powers conferred by sub-section (1) of section 3 read with section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) is hereby published as required by clause (a) of sub-section (2) of section 3 of the said Act, for the information of all persons likely to be affected thereby and notice is hereby given that the said draft will be taken into consideration after fifteen days from the date of its publication in Official Gazette.

Any objection or suggestion, which may be received by the State Government from any person with respect to the said draft before the expiry of the period specified above will be considered by the State Government. Objections and suggestions may be addressed to the Secretary to Government, Department of personnel and Administrative Reforms, VidhanaSoudha, Bengaluru -560 001.

DRAFT RULES

1. Title and Commencement.- (1) These rules may be called the Karnataka Civil Services (Direct Recruitment by Competitive Examinations and Selection) (General) (Amendment) Rules, 2020.

(2) They shall come into force from the date of their final publication in the Official Gazette.

2. Amendment of Rule 2.- In the Karnataka Civil Services (Direct Recruitment by Competitive Examinations and Selection) (General) Rules, 2006 (hereinafter referred to as the said rules), in rule 2, in sub-rule (1), after the item (d), the following shall be inserted at the end, namely:-

“(e) “Selection Authority” means save as otherwise provided in these rules such Authority as may be specified by notification by the Government for selection of candidates to a particular category of posts.”

3. **Substitution of the Expression "Commission".**- In the said rules, except in rule 2, for the word "Commission", wherever they occur the words "Commission or any other Selection Authority specified by the Government", shall be substituted.

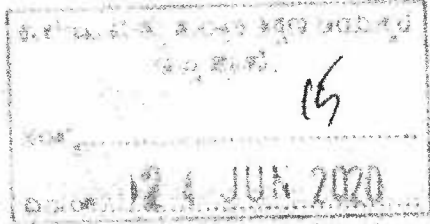
